FAQ's

Do you accept insurance?

- Unfortunately, currently, I do not accept insurance. I realize that may present a hindrance for some people who would really like to partake in my services but in my experience, when someone is ready to address the turmoil in their life, heal from trauma and really put themselves first, they get very creative with coming up with the financial resources to pay. While I don't currently accept insurance, I do offer payment plans, finance options and in some cases, a sliding scale option. In addition, there is a high likelihood that your coaching services can be tax-deductible.

Will working with you feel like being in therapy?

- Yes, it probably will and that's because I am currently completing my Masters in Psychology with a dual emphasis in Marriage and Family Therapy and Professional

Clinical Counseling. I'm working towards Licensure, however I'm not a Licensed Therapist (yet). I'm pre-licensed and a graduate student member of the California Association of Marriage and Family Therapists (CAMFT).

- Interesting to note that a lot of my clients have shared with me that our work together already feels like therapy with an accelerated theme of healing based on coaching tools. So yes, I'm qualified to do the work, but it would be unethical for me to present as a [Licensed] Therapist until I have completed my hours and passed the State Boards.

If you're not a therapist, what qualifications do you have that can help me?

- I am a well-trained trauma-informed, queer affirming Certified LGBT Life Coach, Energy Healer (Certified in Emotion Code Therapy), Certified Law of Attraction Coach, Certified Couples Coach and Certified Master Coach with more than a decade of experience in the field with all the relevant certifications, legal business licenses and insurance required. All of that coupled with a plethora of hands-on experience working with thousands of clients over the years evoking transformation and healing, I am competent and confident. I get results. If you are committed to the process and doing your part which is most important, your life will change for the better.

Can coaching really work on the phone/video/at a distance?

- Yes, in fact most of my coaching is done on the phone and via Skype as my clients are based all over the world. It can be helpful to use a speaker phone or headset when you are on a session so you can take notes and engage in exercises. You get the same results whether in person or via phone/video chat. It's not about will it work – it's more about are YOU willing to put in the work? This process requires YOUR active participation and FOLLOW THROUGH.

What kind of issues can we address in our work together?

- Trauma (sexual, emotional, physical, spiritual), dysfunctional family related issues, coming out, anxiety, PTSD, depression, self-love/self-confidence/self-esteem/self-image/self-care issues, intimate relationship and interpersonal relationship challenges, health/wellness challenges, abundance mindset (overcoming poverty/scarcity mindset).

How often do we meet for sessions?

- Twice a month (every 2 weeks). In the off weeks, you will be implementing the work you are learning and completing your assigned homework.

Do I have to sign a contract?

- Yes, it protects you and me. Once you make your deposit, you will receive a comprehensive contract with all the details necessary to make sure our relationship works seamlessly. The contract is sent via Adobe and when signed, you automatically receive a copy for your records.

How do you accept payments?

- PayPal (includes a small admin fee), Zelle, Cashapp, Venmo, Cashier's check, Wire transfer.

What if I want to end our work together before the contract is over?

- If you would like to end things, let's talk about it. If there is a misunderstanding, let's try to work it out. If we can't resolve the issue or if it's just time to move on, we will leave with best wishes for each other as we go. All fees paid in advance are non-refundable. If you feel unsatisfied with your coaching or energy healing for any reason, please discuss with me directly.

How quickly can I start working with you?

- You will receive a link to my REAL TIME online calendar that shows availability. As soon as you pay your deposit and sign your contract you can schedule your first session.
